Addendum

- 1. In accordance with articles 7 and 9 of the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the third Meeting of States Parties to the Optional Protocol will be convened by the Secretary-General at the United Nations Office at Geneva, on Thursday, 28 October 2010, to elect 5 members of the Subcommittee on Prevention to replace those whose terms are due to expire on 31 December 2010, and to elect 15 additional members to the Subcommittee on Prevention in accordance with article 5.
- 2. In compliance with article 6, paragraph 3, of the Optional Protocol, the Secretary-General, in a note verbale dated 12 May 2010, invited the States parties to the Optional Protocol to submit their nominations for membership in the Subcommittee on Prevention by 11 August 2010. By note verbale dated 12 August 2010, due to the insufficient number of nominations for the expansion of the Subcommittee on Prevention to 25 members, the deadline for nomination of candidates was extended to 11 September 2010. The curricula vitae of 17 candidates received by 11 August 2010 are reproduced in document CAT/OP/SP/8.
- 3. Annexed to the present document are the curricula vitae of the candidates proposed by Armenia, Azerbaijan, Bolivia (Plurinational State of), Ecuador, Guatemala, Kazakhstan, Slovenia, Switzerland, the former Yugoslav Republic of Macedonia and Togo by 11 September 2010.
