ELECTION, IN ACCORDANCE WITH ARTICLES 28 TO 34 OF THE  
INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS,  
OF ONE MEMBER OF THE HUMAN RIGHTS COMMITTEE  
TO FILL THE VACANCY CREATED BY THE DEATH OF  
MS. MARGARETA WADSTEIN (SWEDEN)  
WHOSE TERM WAS TO EXPIRE ON  
31 DECEMBER 2008

Note by the Secretary General

1. In conformity with article 34 of the International Covenant on Civil and Political Rights, the Twenty-fourth Meeting of States Parties to the Covenant will be convened by the Secretary-General at United Nations Headquarters on Tuesday, 8 February 2005, for the purpose of filling one vacancy in the Human Rights Committee.
2. In a letter dated 7 October 2002, the Chairperson of the Human Rights Committee informed the Secretary-General of the death, on 17 September 2004, of Ms. Margareta Wadstein (Sweden).
3. Pursuant to article 33, paragraph 2, and article 34, paragraph 1, of the Covenant, the Secretary-General declared the seat of Ms. Wadstein vacant from the date of her death. By note verbale of 11 November 2004, the States parties to the Covenant were invited to submit nominations, by 12 January 2005, for the purpose of filling the vacancy for a term expiring on 31 December 2008.
4. The curriculum vitae of Ms. Elisabeth Palm, nominated by Sweden, is contained in the annex to the present document.
