#### Addendum

- In a note dated 18 May 2010, the Permanent Mission of Malaysia to the United Nations informed the Secretariat of the decision of its Government to withdraw the nomination of Mary Shanthi Dairiam as a candidate for election to the Committee on the Elimination of Discrimination against Women.
- In a note dated 31 May 2010, the Permanent Mission of the Sultanate of Oman to the United Nations informed the Secretariat of the decision of its Government to present the candidature of Rafiah Suliman Al-Talei instead of that of Ahmed Al-Mukhaini for election to the Committee on the Elimination of Discrimination against Women.

#### **Current position/function**

Working as a journalist in a television station, with focus on women's issues in special reports and news stories related to women's issues. Writing articles in websites and magazines and newspapers. Helping women to learn how to write articles and news stories about women's issues and how to advocate women's rights.

#### Main professional activities

Conducting research for different organizations regarding women's rights and human rights. She has worked for six years with Freedom House. Also she recently gave a speech at George Washington University about women in Oman and the Gulf region. Writing articles about women's issues in Oman on a specialized website that aims to raise awareness among women and society regarding laws and women's rights. Having experienced running for the elections for the Consultative Council in Oman in 2003, she is trying to help women who are interested in running for election, giving advice and support. She has been attending conferences in the Middle East, Europe and the United States of America that discuss women's issues in the Gulf and the Middle East region. She was editor-in-chief of *Almarah* (Woman), which was the only magazine published bilingually (Arabic and English). The magazine focused on and discussed many issues and problems that concerned women in Oman.

#### **Educational background**

She has a master's degree in women's writings in the Gulf and a BA in mass communication and journalism. Participated in many workshops and working groups on women's issues such as women in the media, women and election gender studies and other issues that focus on women. Attended many conferences where issues regarding women and Islam, such as women's rights and feminism in Islam, were discussed.

Worked on research and studies that discussed Oman's position in the Convention on the Elimination of All Forms of Discrimination against Women, Oman's ratification and reservations.
