MEETING OF THE STATES PARTIES First Meeting New York, 11 December 2003

ELECTION OF THE MEMBERS OF THE COMMITTEE ON THE PROTECTION OF THE RIGHTS OF ALL MIGRANT WORKERS AND MEMBERS OF THEIR FAMILIES

Note by the Secretary-General

- 1. The Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families (herein after referred to as "the Convention") was adopted by the General Assembly by its resolution 45/158, of 18 December 1990 and entered into force on 1 July 2003. In accordance with article 72, paragraphs 3 and 4, of the Convention the first meeting of the States parties to the Convention will be convened by the Secretary-General at United Nations Headquarters, for the purpose of electing the 10 members of the Committee on the Protection of the Rights of All Migrant Workers and Members of Their Families (herein after referred to as "the Committee") from among persons nominated by States parties.
- 2. In accordance with article 72, paragraph 3, of the Convention, the Secretary-General, in a note verbale dated 3 July 2003, invited the States parties to the Convention to submit their nominations for membership of the Committee within two months i.e. by 3 September 2003. A first reminder for the submission of nominations was sent on 28 August 2003, by the secretariat to those States parties that had not yet done so. As only nine nominations had been received, a second reminder was sent on 8 September 2003 inviting the States parties that had not yet done so to submit their nominations by 19 September 2003. As a result, a tenth nomination, from Morocco, was submitted on 19 September 2003.
- 3. Annex I contains the names of the persons nominated by States parties to the Convention for membership of the Committee received by the secretariat as of 19 September 2003, in alphabetical order, indicating the States parties that have nominated them. Annex II contains biographical data received by the secretariat from States parties concerning the persons they have nominated. Nominations and biographical data of persons that may be received by the secretariat after 19 September 2003 will be brought to the attention of the States parties in addenda to this note.
