**Election of nine members of the Committee on the Rights of the Child in accordance with article 43 of the Convention on the Rights of the Child as amended by General Assembly resolution 50/155**  
(continued) (CRC/SP/40 and Add. 1 and 2)

1. **The Chairperson** recalled that in the first ballot held at the 19th meeting, only five candidates had obtained the required majority. Accordingly, a second ballot, restricted to the nine candidates who had obtained the largest number of votes in the previous ballot without having obtained the required majority, had been held at that meeting in order to fill the remaining four vacancies on the Committee.

2. *The results of the vote taken by secret ballot were:*

3. *Having obtained the required majority, Ms. Al-Asmar (Syrian Arab Republic) and Mr. Guráň (Slovakia) were elected members of the Committee on the Rights of the Child.*

4. **The Chairperson** said that since fewer than four candidates had obtained the required majority, a third ballot, restricted to the four candidates who had obtained the largest number of votes in the previous ballot without having obtained the required majority, would be held to fill the remaining two vacancies.

5. *At the invitation of the Chairperson, Mr. N'Gbichi (Côte d'Ivoire), Ms. Carvalho (Portugal) and Ms. Pi (Uruguay) continued to act as tellers.*

6. *A vote was taken by secret ballot.*
